



EXERCISE TO TEST MARKET PARTICIPANTS' BUSINESS CONTINUITY PLANS FROM THEIR BACKUP SYSTEMS TO SGX PRODUCTION SYSTEMS

The Exchange would like to inform participants that SGX production systems will be available on Saturday, 28 November 2015 to allow participants to carry out their Business Continuity Plan testing from their backup systems. This is the second of two such windows that SGX provides on a yearly basis. Although participation in this exercise is voluntary, members are strongly encouraged to utilise this opportunity to test and verify their contingency plans.

Please refer to <u>Appendix A</u> for the list of SGX systems available for testing. Participants are reminded that the testing is limited to application login connectivity to SGX's production systems only. Any password change will take immediate effect and remain in force after the test. The details of the connectivity test are tabled in <u>Appendix A</u>.

The schedule for the exercise on Saturday, 28 November 2015 is as follows:
