## **IP ADDRESS CHANGE REQUIRED FOR XML STANDING DATA FTP SERVER FROM 30 NOVEMBER 2015**

### **Executive Summary**

Euronext informs customers that, following the migration of the Disaster Recovery data centre, the XML standing data FTP server on the Disaster Recovery site will no longer be available and from 30 November 2015 customers will be required to change to alternative IP addresses.

Following the migration of the Disaster Recovery Centre to a new location, as detailed in Info-Flash [IF150911CADE](#), Euronext would like to inform customers that the XML standing data FTP server in the Disaster Recovery site will no longer be available and from 30 November 2015 customers will be required to change to alternative IP addresses:

- 156.48.93.155 (via SFTI)
- 156.48.55.1 (via internet)

The address 156.48.250.40 (via internet) will no longer be available as of start of day 30 November 2015.
