

Query accounts to validate the limits in force on any historical date or range of dates and view the progression of limit changes. Limits are time stamped by date, hour, minute and second.

Create customized workflows to ensure all limit change requests are reviewed by the appropriate risk and trading support personnel across multiple organizational levels.
